CMvX: All the Claims Overview

- Vertican has built a new paradigm where each firm has a single interface to vExchange.
- CMvX was custom designed around Collection-Master.
- The goal is to include ALL of the fields for ALL of the claims.
- Other than setting up *VX:#### codes, there is no need to create or setup action codes.
 - The information is automatically uploaded to vExchange because it exists.
- One daily upload includes all of the claims for all of the DTPs.
- vExchange is expanding its list of DTPs.
 - The plan is to have all of the DTPs hosted by vExchange.



CMvX - Benefits

- Single Export
 - With a growing list of Custom DTPs the processing window was getting tight!
- Reduced human errors and setup requirements.
 - Only *vX: codes need be setup relevant CM information is uploaded.
- Required changes to Collection-Master are infrequent.
 - 99 percent of the time DTP changes do not require updating to a new release.
 - New *vX: codes and infinity fields address most of the requirements.
- Centralized DTP at vExchange means that every firm will comply.



CMvX – Matrix Setup

- [4-2-1-6-6-3] – Copy YGC “*CC:” Codes to CvCX “*vX:” Codes
 - As an existing YGC User, your YGC Matrix will be copied to CMvX.
 - You can run it more than once, new/missing codes will be added.
- [4-2-1-6-6-1] – CMvX Updates
 - Enhance CMvX matrix here.
 - Action Codes – Setup additional *vX: codes, 1 paperless entry may trigger 1 EDI code + 10 additional action codes for a total of 11 *vX: codes.
- [4-2-1-6-6-2] – CMvX Financial Matrix
 - Setup *vX: to map for financial codes.
 - Remember to map Subcodes



CMvX – Onboarding

- Onboarding is one of the most difficult tasks in deploying an EDI.
- CMvX & vExchange license fees are included with your CM subscription.
- Analytics Dashboard is included and will report on all your claims!
- The first time you export will take a very long time!
 - [4-2-1-V-3] – Report All Records
 - The system will automatically pick 1/1/1931 as the starting date.
 - You may run Open & Closed Claims Separately (A good idea).
 - The export will create a giant zip file with each record as a separate file.
 - The vExchange team will import the Giant file during off peak hours.
 - Onboard Now! Don't wait for your client.

It's all about the Changes

- Collection-Master updates “Changes” when a value is changed.
- Each field is mapped to a CMvX Record.
- Fields may be updated any way.
 - EDI
 - Merge Pop
 - User Interface
- If it's in Changes, then CMvX Will Report it!
 - There may be some fields that do not update Changes. If so, please report these fields to Client Success, it is our goal for every field to update changes.

Related Party Changes [1-2-2-#]

- Employers, Banks, Adversary Attorney, and DSC
 - Update data in 1-2-2-#
 - Included in IChanges
- CMvX Update will scan any claims assigned to the related party.
- Updated CMvX records will be automatically created for any claim that was assigned to that related party.



Pre-Closed Claims

- Custom\PreClosedQueue.ini
 - [Pre-Closed]
 - Pre-Closed Queues=
 - [Tab] or [Comma] delimited list
- Matching Diary Queues are considered “Pre-Closed”
- Diary Date is the “Pre-Closed Date”
- A Pre-Closed Claim is “Open” and included with Open Claims.
- R271 will use the “Pre-Closed Date”



CMvX – Client Updates – [4-2-1-V-3]

- Daily Export
- Automatically picks the appropriate starting date
- (O)pen (C)losed (A)ll.
 - You can run Open & Closed in separate sessions concurrently.
- Report Changed Records Only
- Index (Automatic)
 - The first step will create fresh indexes to quickly extract the data.
 - This process improves performance and ensures that all the data is included.



N:CMvX.log

- Created every time you run an export
 - If Open or Closed runs, see CMvX_O.log or CMvX_C.log
- Keep a copy for “Baseline performance results”
- Provides details about the export
 - Record Count & Time Spent for each record
 - Total Elapsed Time & Claims Processed
 - Breakdown for various components of conversion
- Identify
 - Performance problems by comparing logs over times
 - Specific components / records that are taking a long time.

Note: Removing a parameter and the value will pull the default value for that parameter.
Leaving the parameter, but removing the value will pull a blank value for that parameter.



CMvX – Clear Cache [4-2-1-V-9-1]

- **Rarely required!**
- Resends ALL of the Claim information.
- Resetting Cache on many claims will delay vExchange processing.
- vExchange will automatically trigger CM “Clear Cache” as required.
 - Trigger CM / vExchange Record (R196)
 - Change Key in CM (R197)
 - Reset the cache on an individual claim if it’s missing (R198).

- CMvX_R2##_DATE – Fields in Master, Debtor, & Property
 - Update the field with a “New Date” to trigger CMvX records.
 - Use “0” to specify today, that will always trigger a new CMvX record.
- VEX_R2### - Fields in Master, Debtor, & Property
 - Update the field with a “New Date” to trigger vExchange records.
 - Use “0” to specify today, that will always trigger a new CMvX record.
 - vExchange Records will trigger all the related CMvX Records including Infinity fields.
- Request new Records
 - WP Scripts
 - Merge Pop
 - CM EDI
 - CMvX

Resending *vX Codes

- Setup Document in 1-7
 - Add PS Comments:
 - PCODE - *vX:#### Required
 - PDATE – Optional
 - Add the new fields at the End, leaving room for other PS Comments.
- Request Document (Paperless or X-Letter Merge)
 - Enter the desired *vX:#### code.
 - Optionally, include a Date.
- Optionally, leave the document description blank.



Costbills & Remittances

- CMvX Record 253 – Live Remittance
- Created Automatically
 - F:\CLSINC\EDI_FILES\CMVX[Forw #]_[Date/Time].CST
 - F:\CLSINC\EDI_FILES\CMVX[Forw #]_[Date/Time].RMT
- In addition to the daily “UPD” file, you should also upload the “CST & RMT” files.
- The “.CS_ & .RM_” files are costbills and remittance reports that were not made permanent (Don’t upload these).



Costbills & Remittances

- CMvX Records

- 210

- Pulls from “FINAN” and includes any transaction that is posted in CM.
 - Is reported the “Next Day” after posting.

- 250

- Pulls from “COLBILLS” and includes any Remittance that is finalized in CM.
 - Is Reported the “Next Day” after remitting.
 - If you reverse a remittance, a (-) R250 will be created, so a single transaction could have multiple R250

- 253

- Is created by the process of finalizing the Costbill or Remittance.
 - Is created Immediately and available to be uploaded
 - Similar to R30 on YGC



Gates & Remediation

- Don't Shoot the Messenger!
 - Gates are defined by your Client.
 - Sometimes Gate Rules need to be Refined.
 - Reach out to your client Account Manager and share why you think the rule should be changed.
- Data With Integrity
 - With YGC, you got Garbage In, Garbage Out.
 - vExchange is intended to ensure that that data is correct and complete.
 - Remediation should be performed at the System of Record.



Gates & Remediation

- Remediation Methods
 - Missing Fields:
 - Update or add the fields in CM.
 - CM Data exists, but is missing on vExchange:
 - Use Re-Send or Trigger records to send to vExchange again.
 - Bad Financial Transactions:
 - Reverse & Re-Post the financial transaction.
 - Manual Remediation:
 - Some things may only be remediated manually.



Gates & Remediation

- Online Remediation Instructions
 - The Gate Rules, Descriptions, and remediation instructions are now being maintained in a database with an interface on the analytics web site.
 - Over time, this feature will be enhanced to include specific notes for your CMvX or QvX interfaces.
