Law firms need improved management of their legal file and serve process.

Today's Challenges:

- Initial suit filing preparing the package to file
- Preparing cost to pay court for filing
 - File and serve states:
 - Court accepts filing and issues suit date and case number and an e-file reference number when e-filing
 - Court may schedule one (or two in California) hearings
 - Court returns conformed file stamped copies of filing
- Subsequent filings Judgment, Lien, Garnishment, Satisfaction and more
- Service of process of one or more debtors
 - Track that service is completed before court hearing date
 - Service attempts tracking
 - Successful service
 - Proof of Service affidavit is filed with court
 - Service information is returned to firm
 - Non-Serve
 - Non-Serve affidavit is filed with court

Requirements

- LEGPROC
 - A legproc record must be created for each new pleading
- DSERVE
 - A dserve record must be created for each contact named in the pleading
- TASKS
 - Appropriate tasks must be added to the accounts
- Contacts
 - Each contact must contain full address
- Documents
 - Appropriate documents must exist on the accounts

Tasks and DDAS



- Tasks can be added via DDAS to execute the following jobs.
- Initial job requests can be requested as File & Serve, File Only or Serve Only. Subsequent Job Requests are File Only.

Invoice and Credit Card Validation

- A new module was created for the purpose of validating vendor cost invoices before creating the corresponding cost requests and matching invoices against a Credit Card statement for e-filing costs.
- Both processes can be set to automatically run on the Job Scheduler but there is also an interface for manually running it, handling rejections and viewing/editing validation rules. Whether run manually or automatically, a log will be created for each process each time it is run. Both processes can also be set up as Dashboard items so users can quickly and easily see if there are invoices that need to be reviewed.





Court Costs and VTFS Invoicing

- Court cost for filing
 - When Court requires Credit Card or firm ACH payment
 - Firm is required to set up ACH and or Credit Card with the court and will pay the court directly
 - When Court requires a paper check
 - Vertican will advance and charge the firm's Vertican VTFS ACH account when filing is accepted
- Process Service fees
 - Process Service is billed when Service is completed, or a Non-Serve is completed. Invoice is sent to firm and at the same time the invoice is sent to firm's Vertican ACH account set up for VTFS Service to be auto paid that day.
- VTFS filing transaction fees
 - VTFS bills a \$2.50 transaction fee for all subsequent filings when the filing is accepted. Invoice is sent to firm and at the same time the invoice is sent to firm's Vertican ACH account set up for VTFS Service to be auto paid that day.



VTFS Dashboard

- The dashboard allows management to review the metrics for Service of Process.
- VTFS Dashboard is available only for firms who have signed up for VTFS service. Once service is installed the Dashboard is available in the maintenance menu.

Email Monitor



- Many states have implemented Court Service by email
- Vertican has built a powerful automation tool to read your firm's court email boxes
- It reads the email only from approved senders (court email address maintenance discards spam)
 - Email document attachments are organized into Docid based on file names and can auto import into document manager
 - If email contains a link to download attachments, email monitor can download most files automatically
- Use keyword pair matching to categorize emails and assign appropriate task codes for follow up
- Emails that can not be recognized, can be read in a user interface
- Email monitor is only available if you are a VTFS subscriber
- Available in more than 20 states
